**Editorial Policy.** *Mathematics of Operations Research* is an international journal of the Institute for Operations Research and the Management Sciences. The journal publishes excellent foundational articles having significant mathematical contents and relevance to operations research and management science. The journal invites articles concerned with the mathematical and computational foundations in the areas of continuous, discrete and stochastic optimization; mathematical programming; dynamic programming; stochastic processes; stochastic models; simulation methodology; control and adaptation; networks; game theory; and decision theory. Also sought are innovative and mathematical theories of inventory, manufacturing, and distribution; organization, finance, and marketing; routing, queuing, and scheduling; data and storage management; location, reliability, search, measurement, and service; artificial intelligence; and machine learning among others. Contributions to mathematics that have special relevance for operations research and management science are encouraged. The emphasis is on originality, quality, and importance. Significant developments in operations research and management science not having substantial mathematical interest should be directed instead to *Management Science* or *Operations Research*.

**Submission of Manuscripts.** Manuscripts should be submitted to the appropriate area editor or, in case the area is not easy to identify, to the editor-in-chief. A manuscript should be submitted by sending an e-mail letter with a PDF (or postscript) file of the manuscript as an attachment. E-mail addresses of the editor-in-chief and the area editors are listed above. The submission procedure is subject to change, so authors should check the journal website at [mor.pubs.informs.org](http://mor.pubs.informs.org) for updates. Authors are also expected to provide a LaTeX file if the paper is accepted. To assist referees, copies of relevant unpublished or inaccessible references should also be submitted, preferably in electronic form. By submitting a manuscript, the authors represent that they consider it ready for publication and that it has not been published or submitted for publication elsewhere. As a condition of final acceptance of a paper for publication in *Mathematics of Operations Research*, the author(s) must indicate if their paper is posted on a working papers website, other than their own. They are responsible for assuring that, if any part of the paper has been copyrighted for prepublication as a working paper, the copyright can and will be transferred to INFORMS when the paper has been accepted. This includes both print and electronic forms of the paper. Authors may post their working papers on websites after acceptance and prior to publication, as long as the sites are not copyrighted or do not serve as formal depositories. **Manuscript Style.** Manuscripts should be in English, double spaced throughout. Manuscripts should include a self-contained abstract of up to 150 words, describing the main results, and should also provide *keywords*. Any *acknowledgments* should appear at the end of the paper, before the references. Full references will be printed as below; abbreviations for journals are to be taken from the most recent index of *Mathematical Reviews*.
